<u>Henry Lipman, DHHS Medicaid Director:</u> Mr. Lipman provided an explanation on the changes in the ProShare regulation. The Board voiced their concerns about the effect to the County budget. Mr. Lipman answered questions from the Board and stated he is looking at ways to enhance revenues for nursing homes.

<u>Departmental Update-Restorative Justice:</u> Restorative Justice Director Mike MacFadzen stated the department is still working remotely. He is starting to think about and make plans for returning to face to face client meetings.

Coronavirus Relief Fund Grant Agreement: County Administrator Shackett spoke about the Coronavirus relief grant and that the County is eligible for \$364,000 in expenses. She explained the process for reimbursement. County Administrator Shackett requested the Board authorize her to sign the contract and request reimbursement. M/Taylor grant the request of the County Administrator, S/Waring. County Administrator Shackett called roll: Waring-yes, DeVoy-yes and Taylor-yes. Unanimous. Motion passed.
